Subject: Informing Changes to ISO/IEC 17065-Based Certification System

Dear Sir/Madam,

Greetings from the Certification Services, Bhutan Food and Drug Authority.

We are writing to inform you about recent updates made to the Procedure for Recertification (Renewal), specifically with regard to Clause 4.1 and Clause 4.2, to enhance clarity, consistency, and timely compliance within the certification process.

Under the revised Clause 4.1, it is now clearly stipulated that a formal notice for recertification shall be issued to the client six (6) months prior to the expiry of the existing certificate. This amendment has been introduced to ensure that certified operators are adequately informed in advance, allowing sufficient time for preparation and scheduling of the recertification audit without disruption to certification validity.

Further, Clause 4.2 has been updated to specify that the certified operator is required to submit the recertification (renewal) application at least three (3) months prior to the expiry of the certificate. This provision aims to facilitate proper planning, timely review of documentation, and completion of necessary audit activities before the certificate lapses.

These changes have been incorporated to address previous gaps related to insufficient timelines between surveillance and recertification audits, and to strengthen the overall efficiency and continuity of the certification process.

We kindly request all concerned to take note of these updates and ensure compliance with the revised timelines.
